Interpretation:

Interpretation will be provided (based on confirmed participation) into the following languages: Czech, Hungarian, English, Polish, Slovenian and Ukrainian.

The costs for interpretation will be divided between individual national delegations as in the past, i.e., these organisations will cover the cost of interpreting for 1 day into their mother tongue. Unfortunately, the Friedrich Ebert Foundation in the Czech Republic cannot release its financial resources for interpretation this year.
