We have pleasure in inviting you to attend the 2nd industriAll Europe Collective Bargaining and Social Policy Conference, which will be held in cooperation with our Slovak affiliates and with financial support from the European Union.

This year's conference will chiefly focus on: working time; wage policies; tendencies in collective bargaining over the past four years; and evaluation of the industriAll Europe Common Demands. We expect up to 200 participants: trade union delegates with experience in collective bargaining, guests, academics and representatives of other European trade union federations and the European institutions.

Simultaneous interpretation at the Conference will be provided as follows:

Active: English, French, German, Italian, Spanish, Swedish, Polish, Czech/Slovak, Romanian, Bulgarian and Serbo-Croatian.

Passive interpretation will also be provided from Portuguese and Dutch.

Conference documentation will be provided in English, French and German.

Travel

At a later stage we will send you a document with detailed information on how to get to the DoubleTree and Lindner hotel from the Bratislava and Vienna airport, from the train station in Bratislava and by car.

Key to seats and reimbursement of costs

We are pleased to confirm that the European Commission funding will allow us to reimburse the travel and accommodation costs for approx. 165 participants coming from EU Member States and Candidate countries. For affiliates who would like to send more participants, a small number of seats will be available, but the travel and accommodation costs of these participants must be met by their own organisations. Participants from non-EU countries and non-Candidate countries (Norway, Iceland and Switzerland) are also welcome to attend – but again their costs must be met by their own unions.

The suggested key to paid places is enclosed.

IndustriAll Europe will pay the accommodation directly (bed and breakfast for the nights of 5 and 6 December 2018). Extra nights must be paid by participants themselves. Travel costs will be reimbursed after the event.

Please note that in order to be reimbursed, participants will have to fill in the enclosed reimbursement form and provide the travel invoice, their flight/train ticket as well as the original boarding passes. The required documents can be handed over to the industriAll Europe representatives present on the spot or sent back after the meeting to the industriAll Europe Secretariat for the attention of Katja Grosser. Please take note of the reimbursement rules mentioned in the attached document.

The participants will have to sign an attendance list on both days (compulsory for the reimbursement).
